I am requesting that the city council consider making the current 5k run route used by the Water Festival and others as the sole approved running course in the city. The benefits of this are as follows:

It has proven to be a safe route (less liability for the city)

Minimum impact on citizens who are not involved in the race (fewer complaints)

Manpower requirements are minimal and can be staffed without detriment to primary duties

Planning and requirements are established (eliminates confusion)

The route takes coordination with BCSO and the USCG which has never been an issue and we can direct people to the appropriate points of contact with those agencies.
