

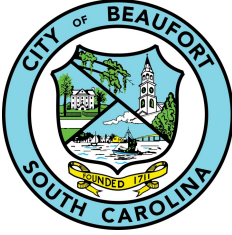

Comprehensive Plan Schedule

July 13<sup>th</sup> – Present working draft of comprehensive plan to council (at work session) and to staff (hard copy and Dropbox link)

July 14<sup>th</sup> – Post working draft of comprehensive plan on city website; notify media; notify MPC, Town of Port Royal, Chamber of Commerce, Downtown Merchants Association, HBF, CCL, SICC, and Neighborhood Associations.

July 14<sup>th</sup> thru August 20<sup>th</sup> – Public will be able to electronically submit comments.

July 19<sup>th</sup> – Discuss working draft of comprehensive plan with MPC.

August 12<sup>th</sup> – Hold in-person, public sessions: day, from 2pm – 4pm; night, from 5pm – 7pm.

August 20<sup>th</sup> – Close electronic public comment time for the comprehensive plan.

August 21<sup>st</sup> thru September 7<sup>th</sup> – Incorporate comments from council, planning commission, staff, and the public. Create Priority Investment Element.

September 7<sup>th</sup> – Announce final schedule at Neighborhood meeting.

September 14<sup>th</sup> – Public Hearing on proposed comprehensive plan.

September 20<sup>th</sup> – Present draft-final of the comprehensive plan to the MPC.

September 28<sup>th</sup> – Present draft-final of the comprehensive plan to council at work session.

September 29<sup>th</sup> thru October 5<sup>th</sup> – Incorporate final revisions.

October 12<sup>th</sup> – Present final comprehensive plan to council for approval.
