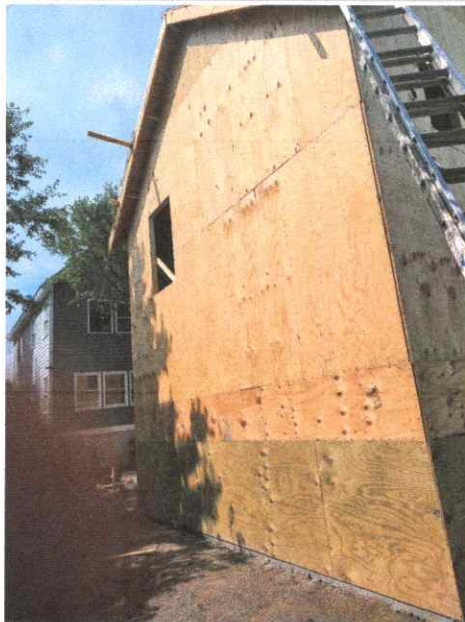

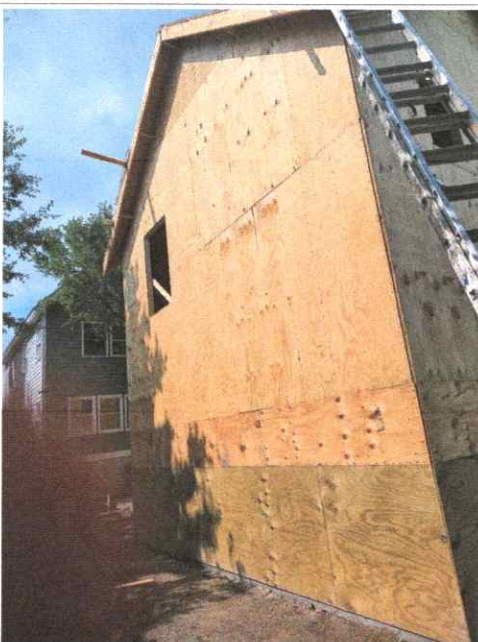


Photo Four Caption: **SIDE**
